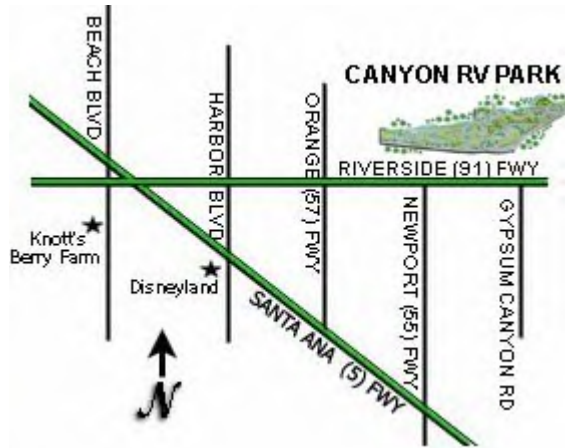


Show Site
